## Adoption Contract

If I adopt a dog from Seattle Pug Rescue ("SPR"), I agree to the following conditions:

1. To keep this dog in my personal possession and to provide proper and sufficient food, water, shelter, grooming and humane treatment at all times.
2. To spay or neuter this dog within thirty (30) days at my own expense if dog is not already altered. Proof of spay or neuter will be provided to SPR in writing within ten days of surgery. I will not allow this dog to be bred under any circumstances.
3. To provide veterinary care immediately if this dog becomes sick or injured, and to vaccinate as recommended by SPR.
4. During the two week trial adoption period, any veterinary care must be pre-approved in writing (email is acceptable) by SPR and/or provided by the official veterinarians of SPR. During the two week trial adoption period, any veterinary services obtained by me without pre-approval or through my personal veterinarian are my sole responsibility.
5. To provide this dog with an ID tag secured to a collar or harness that will be worn at all times.
6. To obey any and all animal control regulations governing the area in which I reside, and to license this dog according to said regulations.
7. Not to sell, trade, transfer ownership or dispose of this dog in any way, but to notify SPR if I must relinquish custody of this dog. This includes release and or transfer to family members.
8. To follow the medical guidelines laid out by SPR should the dog require surgery. This is with respect to the proper anesthesia protocol required for the pug breed that may differ from other breeds.
9. To allow an SPR representative to examine the dog and its living conditions, and to surrender it to said representative for return to the organization if conditions are found unsatisfactory.
10. To assume full responsibility for this dogs' actions, including any damage done by this dog.
11. To keep this dog as a household pet and companion. The dog will sleep inside the house.
12. To not leave the dog outside unattended for extended periods unsupervised, while the family is away from the home, or in inclement weather. This dog must not be subjected to high or low temperatures. The dog will never be chained. The dog will not be allowed to run loose except in a fully fenced yard or at an off-leash dog park.
13. To never allow this dog to be transported in the open bed of a pickup truck or similar vehicle.

# Adoption Contract (continued)

I have read this entire Adoption Contract before signing it. I hereby agree to abide by the terms of this Adoption Contract.

I understand that SPR is not making any representations or warranties about the dog's temperament or behavior. I acknowledge and agree that SPR is not responsible for any injury, damage, or harm caused by the adopted dog, and I hereby release SPR from any and all liability for any injury, damage, harm, expense or liability I incur relating to the adopted dog.

The adopted dog is the sole property of SPR until the non-refundable adoption fee has been paid in full. I also understand that SPR may reclaim the adopted dog if, in its opinion, any of the above conditions are not being met. I understand that I will be liable for any and all fees and costs incurred by SPR arising out of the enforcement of this Adoption Contract.

## Obtaining Veterinary Records

I agree to contact Norton's Ark Veterinary clinic at 425-822-7847 (voice and fax) or nortons.ark@comcast.net (email) or to have my vet do so, after the two week adoption trial period to obtain this dog's medical records. I understand that as this is a closed adoption I may not receive the original complete medical records so as to protect the original owner's identity.

This Adoption Contract is the complete statement of the understanding between SPR and me.
